Security Light Maintenance Agreement

To provide security and peace of mind to its members and to protect our members from the actual costs associated with repairs, Sumner-Cowley Electric Cooperative will provide a new LED security light for a one-time installation fee of **\$75.00** and a maintenance plan to its members under the terms and conditions of this agreement.

The security light must be installed on a Cooperative owned pole, which is deemed suitable for such installation by the Cooperative. The security light shall not have any external switches or controls that circumvent the photoelectric operation of the security light. This maintenance agreement does not include repairs or replacement of any electrical wiring used to provide electric service to the security light if provided by the member. The member must sign and abide by the maintenance agreement for the term and fee specified.

Terms and Conditions for Security Light Maintenance Program

All Cooperative members will be afforded the opportunity to participate in the maintenance program, provided they meet the terms and conditions. This includes meeting the following specifications for installations and repairs of security lights.

- A. Maintenance Program can only be applied to a security light attached to a Cooperative owned and approved pole at member's location. It must be a light that the Cooperative installed, which can be serviced with replacement parts stocked by the Cooperative.
- B. Security lights may be installed at different locations for the same member, provided all the above terms and conditions are met. (Light must be installed on pole owned by Cooperative and electric service to light is metered)
- C. Security lights installed by the Cooperative must remain exclusive property of Sumner Cowley Cooperative.

SECURITY LIGHT MAINTENANCE AGREEMENT

Agreement made, _____, **20__**, between the Sumner-Cowley Electric Cooperative, Inc., (hereinafter called the "Cooperative") and _____ (hereinafter called the "Member").

The Cooperative agrees to install, maintain and furnish the necessary connections to operate a photoelectric relay controlled security light (dusk to dawn) located at _____.

The Member agrees to the one-time installation fee and to participate in the maintenance program at a monthly rate **\$5.95**. This fee will be added to the Member's monthly electric bill. The Member agrees to participate in the maintenance program for additional lights at a monthly rate of \$3.00 per light.

The term of this agreement shall be **four (4) years** and shall continue for each subsequent year thereafter unless terminated by either party after the initial four (4) year period.

The Cooperative reserves the right to amend and/or change any part of this agreement at any time.
