# The Cooperative Spirit Shines **Bright This Christmas Season**

As we near the end of another year and look forward to the Christmas season, I'm reminded of what makes our cooperative truly special — the people we serve and the principles that guide us. This time of year is filled with gratitude, generosity and reflection, and those same values are at the heart of everything we do as your local electric cooperative.

One of the most visible ways we demonstrate the cooperative difference is through the return of capital credits. I'm pleased to share that your board of directors has authorized a general retirement totaling \$586,315.30 to be returned to our members. This retirement includes the remaining balance of the 1999 allocation and \$100,000 from the year 2000 allocation, keeping us aligned with our financial policy of maintaining a 25-year retirement rotation. Current

members who received electric service during those years will see a credit on their December bill. Former members will receive a check mailed to their last known address.

Capital credits are one of the most tangible benefits of belonging to a cooperative. Unlike investorowned utilities that return profits to shareholders, electric cooperatives operate at cost. Any margins we earn are allocated back to you, the memberowners, based on your patronage for the year. When the cooperative's financial condition allows, those margins





# Sumner-Cowley Awards Over \$18,000 to Projects **Through Concern for Community Fund**

Guided by cooperative principle No. 7, Concern for Community, Sumner-Cowley Electric Cooperative is committed to supporting the people and organizations that make our rural area a better place to live and work. In April 2025, the Concern for Community Program was established to give back to local organizations through the proceeds of the discounting process of early paid out capital credits,

reinforcing our dedication to the communities we serve. The fund is overseen by a committee made up of one representative member from each of the seven districts across our service territory.

Eight applications have been submitted this year by schools, churches, nonprofits and volunteer organizations, all with projects aimed to better serve their communities. This year's recipients are:

- ► \$3.580.39 TO WELLINGTON CHRISTIAN ACADEMY FOR SECURITY CAMERAS FOR THEIR NEW CHILDCARE AND PRESCHOOL CLASSROOMS. These security cameras will give parents peace of mind that their children are safe and are being properly cared for as it adds an extra level of security and transparency.
- ▶ \$8.000 TO THE WELLINGTON FIRST CHRISTIAN CHURCH FOR THE REPLACEMENT OF THEIR BAPTISMAL UNIT. Their baptistry is not only used by the First Christian Church but they welcome other church groups in the area to use it as well.
- ► \$6,381.46 TO THE NORWICH AMBULANCE SERVICE FOR **REPLACEMENT BATTERIES AND A NEW CHARGER FOR**

THEIR ZOLL AUTOPULSE RESUSCITATION SYSTEM. This system improves positive patient outcomes by delivering uninterrupted compressions during cardiac arrest emergencies and is especially vital during transport or in confined environments.

► \$1,000 TO CONWAY SPRINGS HIGH SCHOOL FOR THE **EXPANSION OUTDOOR WILDLIFE LEARNING SITE (OWLS).** 

The OWLS area is located at Conway Springs High School and has been a collaborative effort since its inception between CSHS students and staff, area businesses, and local community members. This area is open to the community to enjoy and provides learning opportunities for students to learn about native wildlife and conservation.

These are just a few examples of how SCEC demonstrates its dedication to the cooperative principles that guide its operations. The donations to these community projects illustrate how collective support and reinvestment can create lasting benefits.
